A New Public Service Event in Boston

After 16 years of sponsoring a Bike-A-Thon to benefit youth bicycle programs, Bikes Not Bombs has realized the value of reliable communications. BARC has been asked to support this event on Sunday, 23 May 2004. 185 riders are expected, and we are tasked with monitoring rest stops, follow vehicles and a few shadows. There will be no assignments on the streets.

We will assemble at 0800 at a restaurant parking lot in Roxbury Crossing. Cars can be left there, as the lot is secure. Transportation will be provided to the outlying rest stops, but you may proceed directly. There are three concurrent courses - 15 mile, 25 mile, and 62 mile, each with separate rest stops and vehicles.

The shorter courses should be finished by 1400 and the longer course should finish by 1630. All finishes are at Mississippi's Restaurant where a gourmet dinner buffet will be provided.

SKYWARN is a program sponsored by the National Weather Service (NWS) to increase information regarding surface weather conditions during critical weather events. If you haven't had a refresher in four or five years, the NWS recommends you consider attending a current session.

Disaster Training Opportunity

The Salvation Army, our host for BARC meetings, has requested the help of BARC members to support a communications intensive exercise for the Salvation Army Emergency Response. It is scheduled for **Saturday, May 15, 2004**. This exercise will be conducted, rain or shine, at their 120 acre youth camp, Camp Wonderland, in Sharon, MA., from 0900 through mid-afternoon.

Hams will support the Sharon EOC, the Communications Vehicle, a message center, the staging area, and Disaster Canteens. Shadow supports for key staff will also be provided. Partial day commitment is acceptable since this will afford us practice in relief operations.

Lunch, drinks, and snacks will be provided during the day. An evening meal, prepared on-site from the 50 ft. Salvation Army Regional Disaster Kitchen, will be offered to all volunteers. This same mobile unit served thousands at the WTC.

his *all radio* exercise is designed to test the teamwork and performance of new members of the local Salvation Army Disaster Services Organization (DSO). All of the DSO team members have completed Basic ICS training courses, and many were at WTC. However, this is the first time for all Massachusetts DSO teams to respond and work together at a local disaster event under the Incident Command structure. Their further limitation is that they will have to rely on *only radio communications*. No cell phones will be permitted!

This will be a great test of both our SATERN and BERT members to provide the communications support we promise to our hosts, and advertise to the community in general. Our plans are for BERT to manage all field radio operations, including the new mobile Communications Van. Most radio communications will use simplex frequencies, with some local repeater backup.

In addition to the hams, the Salvation Army is calling for many general Disaster Volunteers. Hands-on field training will be conducted in non-ham response support activities. These will include canteen operation, mass feeding, shelter setup and operation, and other related tasks needed in supporting any major disaster response agency.

While this exercise is not an ARES scheduled event, ARES Leadership participation and the use of ARES resources have been requested. Members from the ARES EC staff, and local and state emergency management have been invited as official observers to critique the drill.

Do you need time with your family? If they are old enough to safely manage themselves without your supervision, bring them along. They can be actors for the day. No disaster exercise looks real unless there are "victims." Plans are to assemble some "simulated victims" and create real life scenarios as part of the responder's training. Give your family a chance to see what you've been training for and what you do. At the same time they can enjoy the day outdoors at Camp Wonderland.

Ham volunteers are asked to contact either Blake, K1BTH, Frank, N1DHW, or Bill Foley, KB1GLF (info below) to support this worthwhile event. BARC and BERT members who respond will be contacted and given more information as plans for the exercise are updated. Your early response will help in our planning.

As a club, we've accepted their generosity - now it's time to give back. At the same time we can prepare ourselves for potentially dangerous times ahead in this summer's Boston area events.

New Morse "@" Character Is Now Official

The International Morse code officially gains a new character on May 3. That's when the now-familiar "@" symbol joins the Morse lexicon as the letters "AC" run together (---.). Known as the "commercial at" or "commat," the @ symbol never rose to the level of usage that demanded a unique Morse character until it gained currency as a critical component of e-mail addresses during the past decade or so.

Last December, the International Telecommunication Union Radiocommunication Sector (ITU-R) Study Group 8 agreed on the wording of a Draft New Recommendation ITU-R M.[MORSE] that specified the international Morse code character set and transmission procedures and included the new Morse code character.

The pending change has attracted some attention in the media, including mentions on National Public Radio's *All Things Considered* and in *The New York Times*.

SWLs May File BPL-Interference Complaints

FCC Part 15 rules prohibit interference to licensed services from unlicensed devices. This means that, with limited exceptions, short-wave listeners (SWLs) may file formal complaints if broadband over power line (BPL) signals interfere with their reception. "There is no doubt that international broadcast listeners have standing to complain about interference to the reception of foreign broadcast signals," says ARRL General Counsel Chris Imlay, W3KD. "One does not have to be a licensee of a transmitter in order to receive harmful interference from a United States-based RF source and have standing to complain about it."

Listeners to international short-wave broadcasts originating in the US, Imlay explains, do not have standing to complain, however,

because they are not the target audience for such broadcasts. Imlay says that while FCC and court cases involving standing to file are complex, "the cases are clear that the allegation of suffering actual electromagnetic interference to reception of a broadcast service, even one generated internationally, from a domestic RF source, is sufficient in every case to demonstrate standing to file a complaint."

International Telecommunication Union Radio Regulations require member nations to "take all practicable and necessary steps to ensure that the operation of electrical apparatus or installations of any kind, including power and telecommunication distribution networks, but excluding equipment used for industrial, scientific and medical applications, does not cause harmful interference to a radiocommunication service."

BARC VE Session

The Boston Amateur Radio Club holds its monthly VE session on the second Monday of each month. Sessions are held at 7:00 pm at the Pierce School, 50 School St in Brookline, Room 110, next to the cafeteria. Future exam dates are listed below. A map is shown on page 7 of this newsletter.

If the Brookline public schools (or the Pierce School itself) is closed due to inclement weather or other problems, the exam session for that month will be cancelled. Otherwise, the exams will be on the second Monday of each month (first Monday in October due to Columbus Day).

There is a free parking garage at the circular driveway. If driving, enter School Street from the Washington St side (opposite 394 Washington), rather than from Harvard St. Check: http://www.barc.org/barc/school_map.gif for more info. This map also appears on page 7 of this newsletter.

- Your current license *and a photocopy for the ARRL*, if you are upgrading

- Valid ID (picture ID preferred)
- A pen and a calculator (if you want to)
- **\$12.00** (good for all the tests you take at that session, except for retests)
- Note that code tests are no longer free. Those taking the code test only will also have to pay the \$12 fee. Code and written tests can be taken together at the same session for a single \$12 fee.

The needed FCC forms will be provided.

Form Confusion

The BARC Membership Information form for 2004 may be misleading regarding membership dues. The block headed "1 December to 31 July" is for the whole 2004 year when paid between those dates. The block headed "1 August to 30 November" denotes the remainder of the 2004 year when paid between those dates.

If you have occasion to accept a form from a prospective member, please be sure that the dues are accurately determined.

FCC to Stop Accepting Pre-December 2003 Form 605

Effective with Monday, May 3, receipts, the FCC's Wireless Telecommunications Bureau will dismiss any applications filed on an FCC Form 605 issued earlier than December 2003. Form 605, *Quick-Form Application for Authorization in the Ship, Aircraft, Amateur, Restricted and Commercial Operator, and General Mobile Radio Service*, is the hard-copy version of the Amateur Service application. The change does not affect applicants filing on-line with the Universal Licensing System (ULS) at <http://wireless.fcc.gov/uls/> said the FCC, which is encouraging on-line filing.

ARRL VEC Manager Bart Jahnke, W9JJ, says the Form 605 announcement will affect the way ARRL has been making FCC Form 605 available. He says the League's widely distributed March 2001 Form 605 in a three-sheet ivory/buff-colored package with perforated pages will become obsolete for applications the FCC receives on or after May 3.

In the wake of the FCC's unexpected announcement, the ARRL is developing a replacement package that could require several more pages. It hopes to have it ready in time for Hamvention May 14-16.

The FCC has been accepting both older and current Form 605 applications that included a line (Item 9a) for a Taxpayer Identification Number, a Social Security number for an individual. The FCC would then issue the applicant an FCC Registration Number (FRN) without additional paperwork. All amateur applicants must have and use an FRN when filing an application such as Form 605 with the FCC. Applicants attending VEC test sessions can still supply a Social Security number, which will result in automatic Commission Registration System (CORES) registration.

All amateur applicants must have and use an FRN when filing an application such as Form 605 with the FCC. Under the system going into effect in May, applicants not yet registered in CORES and filing on paper will need to file FCC Form 160, CORES Registration to obtain a FCC Registration Number (FRN). After the FCC has issued an FRN, applicants also might want to file FCC Form 606 to associate the FRN with an individual's license record(s) and call sign(s). CORES registration data and FCC license data are maintained in separate FCC databases.

The completed Form 160 goes to a unique Washington, DC, FCC address to obtain the applicant's FRN. Once the FCC issues an FRN to the applicant, this number must be used when filing FCC Form 605, which goes to the FCC's Gettysburg, PA, office. The two forms may not be mailed to Gettysburg together. Applicants need to have obtained an FRN via Form 160 before they can file a Form 605.

ARRL recommends that all amateurs file an on-line or paper Form 606 to associate their FRN with their license record(s) and call sign(s) in the FCC license database. Jahnke says the easiest way is

to do this electronically via the ULS, and the process now is fairly straightforward.

Trying to Get Through to the FCC?

-- ARRL Letter, 26 March 2004

Forget your CORES/FRN password? It's possible to reset your CORES/FRN (Commission Registration System/FCC Registration Number) password via the FCC Web site for electronic application filing. This might come in handy if you have forgotten your password, need to change it to another password or were automatically registered for CORES through a Volunteer Examiner Coordinator and don't know your password.

Visit the secure "Forgot Your Password" web site <https://esupport.fcc.gov/password.htm> and complete all the required fields. You will need to supply your FCC Registration Number (available via ULS or through many on-line call sign servers, such as ARRL's) as well as your Taxpayer Identification Number (TIN), which is typically your Social Security number. Applicants also will need to supply name, email address and telephone number.


